Eligible students will receive up to a \$200 voucher per course (non-refundable) to offset the cost of textbooks, technology fees, and embedded resources (if applicable). \* This voucher cannot be rolled forward to cover costs of future courses, nor can it retroactively apply to past courses. Students must elect to receive textbooks through Indiana Wesleyan University/Tree of Life in order to utilize the textbook portion of this benefit.

\*The one-time Educational Resource Fee and Graduation Fee are not covered by the voucher.

***By signing, I confirm my understanding that falsification of this document can result in the loss of the above discount with IWU. While IWU makes it a priority to make students aware of available discounts during the enrollment process, the responsibility ultimately rests on the student to notify IWU if they should become eligible. I affirm my understanding that tuition discounts may only be retroactively applied back to the beginning of the current financial aid period, or the equivalent for those not utilizing Federal Student Aid.***
