*Describe the extent and nature of enforcement authority of campus security authority personnel:*

The primary function of the CSA is to report via the Maxient system, all incidents concerning student safety. Once entered in Maxient, the Director of Campus Police & Emergency Management will determine if the crime is Clery reportable. CSA's will also assist in emergency notification and evacuation procedures. CSA's undergo annual training to ensure they are aware of their responsibilities. CSA's do not have the power to make arrests.

*Describe the working relationship of campus security authority personnel with state and local police agencies:*

Since the Louisville Education Center consists of a single building, no formal written agreement exists with local law enforcement. The Louisville Education Center is in the jurisdiction of the Jeffersontown Police Department. The Louisville CSA is aware to contact them in the event of an emergency.

*Describe programs that inform students and employees about:*

*(a) Campus safety and security*

The university does not require students to undergo any specific security or crime prevention program. However, the university strongly encourages the campus community to look out for themselves and one another, to be aware of their responsibility for their own security and the security of others, as detailed in the Annual Security Report. Furthermore, CSA's are trained annually on campus safety and security.

*(b) How to report a crime:*

Students and employees are informed on how to report a crime via the distribution of the Annual Security Report, and by posters hung in visible places. CSA's are trained annually on how to assist students and employees on crime reporting.

*(c) How to prevent crimes:*

The IWU Annual Security Report details ways to prevent crimes. CSA's are trained annually on how to help prevent crimes.

### Section 3: Statements of Policies and Procedures

IWU Alert is the Wireless Emergency Notification System for the IWU Marion campus and regional education centers. IWU Alerts are sent using the RAVE Mobile Safety system. It is used by IWU as a way to instantly reach mobile devices and e-mail when an urgent situation needs to be communicated. IWU Alert notifications are specific to the person's chosen IWU location(s). Each regional site has a RAVE administrator that is able to send notifications. All on-site students and employees are automatically signed up for IWU Alerts.

CSA's will post a "crime alert," advising that there has been a known systematic pattern of a crime or series of crimes that may pose a threat to the safety or welfare of the campus. The crime alert will be sent to mobile devices and email. In addition, these timely reports can be posted in visible and accessible areas on the campus such as bulletin boards. The crime alerts will not be limited to the guidelines in the uniform crime report of the FBI.
