Student 2022 Tax Filers: Check the box that applies

The student and/or spouse has used the FA-DDX when completing the FAFSA to transfer 2022 IRS income tax return information into the student's FAFSA.

If 2022 income tax return information for the student (or spouse, if applicable) was not available or could not be used, the student should provide the institution with a 2022 IRS Tax Return Transcript(s) or a signed copy of the 2022 income tax return and applicable schedules.

A 2022 IRS Tax Return Transcript may be obtained through:

• <u>Get Transcript by MAIL</u>– Go to <u>www.irs.gov</u>, click "Get Your Tax Record."Click "Get Transcript by Mail."Make sure to request the "Return Transcript" and *NOT* the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.

• <u>Get Transcript ONLINE</u> – Go to <u>www.irs.gov</u>, click "Get a tax transcript." Click "Get Transcript Online." Make sure to request the "Return Transcript" and **NOT** the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.

• <u>Automated Telephone Request</u>- 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.

• <u>Paper Request Form</u>– IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

• The student and/or spouse were employed in 2022 and have listed below the names of all employers, the amount earned from each employer in 2022, and whether an IRS W-2 form or an equivalent document is provided. [Provide copies of all 2022 IRS W-2 forms issued to the student and spouse by their employers]. List every employer even if the employer did not issue an IRS W-2 form.
